- 3.1 Our charity organization is a non-profit subsidiary of the Church, The Evolution [T05SS0159B]. However, our charity organization will maintain the sole objective of helping the residents in our community, and will not impose any religious agenda in its activities or services, such as the propagation of religious beliefs, any form of prayer, and distribution of materials.
- 3.2 Our charity organization receives funding from the Church, The Evolution and from public donations, and the funds go directly into community betterment. No funds from our charity organization will go to the Church, The Evolution.
